The training was 2 days of '8ways' Aboriginal pedagogies / ways of learning and how they can be incorporated into teaching, discipline policies etc. The course covered non-linear ways of learning, creating and strengthening community links, non-verbal communication, land links and much more. 8ways is learning through culture, not teaching culture. It was really beneficial to have time with the whole staff together.	
	Thank you to Sarah for being part of the head teacher maths recruitment panel. It was a successful outcome with Curtis Miles appointed as head of maths. Janine met with School Locker today. They are going to price the school shirts in hemp and also look at revisioning the school logo. A Caitlin Clarke design has been purchased by the school and could be incorporated into a new logo. School Locker will research what graphics can be Incorporated onto hemp clothing and also the longevity of hemp and care of items.

8. Fundraising and grant applications update

> A grant application was made to Splendour in the Grass for \$13k for computers. The grant recipients will be announced at the end of August.

> Wandy has been investigating the options for the colour run. Two companies were approached, one of which does St Finbars colour run. One company sets up the website and provides all the supplies. Students raise money and chose from the relevant price packs. This structure gives 60% of funds raised to the school, 30% is used for prizes for raising money and 10% is retained by the company. There is no upfront cost to the school. The other model requires a payment of \$1500-3000 to buy supplies, then the school has to recoup the costs through tickets sales etc. Lara to consult with SRC to discuss options for raising funds or selling tickets.

> Emma submitted an overview of the trivia night. Sue Charles has advised the golf club has availability to host the trivia night on 17th Nov. It was agreed to proceed with this date. The golf club will charge \$30 per meal. The ticket price will be set to include a donation to the fundraising. The P&C will launch the raffle at the start of term 4 and start collecting prizes at the beginning of Sept.
